# CONFERENCE ON "LESSONS LEARNED FROM THE INFLUENZA PANDEMIC A(H1N1)2009

This conference was held on 1-2 July 2010 in Brussels. Experts discussed 4 major topics: surveillance, mutisectoral aspects, communication and medical measures. Among the conclusions, experts agreed that there is a need for studies that are independent from the pharmaceutical companies including for the monitoring of the vaccination coverage. They also agreed that it is necessary to review purchasing procedures to include elements such as the flexibility to adjust the quantities ordered to actual needs. <u>More</u> – <u>Conference conclusions</u> – <u>More on the Conference</u>

### **INFORMAL MEETING OF EPSCO COUNCIL, 6-9 JULY**

### 1. ON PUBLIC HEALTH

On 6-7 July the informal EPSCO council meeting was dedicated on public health matters. Following issues were addressed:

1. The **fight against cancer**: all member states are engaging to execute long-term national cancer plans until 2013. Additionally, the European Ministers of Public Health agreed to maximum effort to ensure that screening will be available for population segments at risk for breast cancer, colon cancer and cervical cancer.

**2. The management of the H1N1 flu** pandemic: the ministers agreed on the following 5 priorities:

- The conclusions of the Conference will be transmitted to the WHO Executive Committee
- Revision of the EU Pandemic Readiness Plan
- A fast registration procedure and more rapid information about vaccines
- Development of procedures for common acquisition of vaccines and antivirals: The ministers requested that the Commission should develop a procedure for common acquisition on a

voluntary basis. Commissioner Dalli announced that he would submit a proposal for a common acquisition platform on a voluntary basis by autumn 2010.

### 2. ON EMPLOYMENT POLICIES

The meeting on 8 July was dedicated on employment policies. Ministers agreed that employment policies and the EPSCO Council should occupy a central position in the new economic governance and be at the heart of the Europe 2020 Strategy. # INTERNATIONALLY ACTIVE SMES YIELD BETTER RESULTS

25% of EU 27 small and medium-sized businesses (SMEs) export or have exported at some point during the last 3 years. SOLVENCY II: FIFTH QUANTITATIVE IMPACT STUDY: CALL FOR ADVICE AND TECHNICAL SPECIFICATIONS

The Commission services have sent CEIOPS a Call for Advice along with the final technical specifications for the fifth quantitative impact study on Solvency II (QIS5). **European insurance and reinsurance undertakings are being asked to participate in the QIS5 exercise from August to November 2010**. CEIOPS will publish the report on the results of the QIS5 exercise in April 2011. More

### CONSULTATION ON BARRIERS HAMPERING MORE EFFICIENT AND FAIRER RETAIL SERVICES IN EUROPE

The Commission has adopted a report that identifies key issues potentially hampering more efficient and fairer retail services within the Internal Market and is now launching a public consultation on the report to determine future policy priorities in this domain. Reduced accessibility to basic retail services, scarce information on retail offers beyond local markets, slow growth of ecommerce, potentially abusive contractual practices throughout the retail supply chain, lack of transparency on quality labels, unsatisfactory functioning of the retail service labour markets as well as very different approaches to environmentally friendly retail services across the EU have been identified as key issues potentially hampering the retail sector. The deadline for consultation responses is 10 September 2010. The responses will feed into measures that the Commission will propose in the autumn as part of the Single Market Act. More - FAQ

# COMMISSION CONSULTS ON IMPLEMENTATION PROCESS OF SERVICES DIRECTIVE

The transposition deadline for the Services Directive was the end of December 2009. Since January this year, all EU Member States have engaged, together with the Commission, in a peer review process of mutually evaluating certain aspects of their national legal frameworks applicable to service providers. This innovative working method, known as the "mutual evaluation process" was foreseen in the Directive. It is in the context of this process that the Commission is inviting interested parties to share their views on those aspects of national legislation which are being discussed by Member States in the "mutual evaluation process". #### COMMISSION SEEKS CONTRACT LAW SOLUTIONS TO SMOOTH SINGLE MARKET FOR CONSUMERS AND BUSINESSES

Contracts are the basic building blocks for relationships between businesses and consumers. The EU's Single Market is built on contract laws. However, businesses - particularly small and medium-sized companies - are hampered in crossborder sales because they must follow different contract laws for each of the EU's 27 Member States. Only 8% of consumers buy online from another Member State. In addition, 61% of crossborder sales are rejected because traders refuse to serve the consumer's country. This is largely due to regulatory barriers and legal uncertainty about the applicable rules. To address some of these problems and boost the potential of Europe's Single Market, the Commission proposed in a strategic policy paper, several options for a more coherent approach to contract law. The goal is to bring more legal certainty for businesses and simpler rules for consumers. A public consultation on the policy paper will run until 31 January 2011. More

### PATENTS: COMMISSION PROPOSES TRANSLATION ARRANGEMENTS FOR FUTURE EU PATENT

A proposal on translation arrangements for a future EU Patent, the final element needed for a single EU Patent to become a reality, has been presented by the Commission. Today, obtaining a patent in Europe costs ten times more than one in the US. This situation discourages research, development and innovation, and undermines Europe's competitiveness. The new proposal builds on the successful three language system at the European Patent Office (EPO) and, if adopted, would drastically reduce existing translation costs. <u>More</u> -<u>FAQ\_EN</u>

## PHARMACEUTICAL AND MEDICAL DEVICES SECTOR

#### ANTITRUST: COMMISSION WELCOMES DECREASE OF POTENTIALLY PROBLEMATIC PATENT SETTLEMENTS IN EU PHARMA SECTOR

The number of patent settlements in the pharmaceutical sector that are potentially problematic under the EU's antitrust rules fell to 10% of total patent settlements in the sector in the period July 2008 to December 2009 compared with 22% in the period covered in last year's inquiry into the pharmaceutical sector (January 2000-June 2008). The amount of money involved in the settlements, between the so-called "originator" pharmaceutical companies and producers of generic drugs also appears to have decreased from more than €200 million recorded in the sector inquiry period to less than €1 million in the more recent period, shows a Commission report on the monitoring of patent settlements. It is good news for consumers that cheaper generic drugs are not being unduly kept out or delayed into the market. The Commission will continue monitoring the sector to make sure that the settlements in the sector are not delaying entry of generics in the market or do not contain other restrictions that would be problematic under EU competition law. <u>More</u>

## ANTITRUST: COMMISSION WELCOMES COURT JUDGMENT IN ASTRAZENECA CASE

The Commission welcomes the judgment of the General Court (Case T-321/05) which largely dismisses the appeal by the pharmaceutical companies AstraZeneca AB of Sweden and AstraZeneca Plc of the UK. The General Court's ruling concerns the Commission decision of June 2005 that imposed a fine of €60 million on AstraZeneca for misusing the patent system and the procedures for marketing pharmaceutical products to prevent or delay the market entry of competing generic medicinal products (see IP/05/737). # RESEARCH

## EU-FUNDED FOOD RESEARCH

Eight EU-funded research projects on food quality and safety were presented on 8 July at a conference at the EP. One project, ISAFRUIT, has found that eating two apples (300gr) a day can help reduce cholesterol by 10% and that dipping apples and peaches in hot water at precise temperatures can reduce brown rot by 80% and remove e-coli and salmonella bacteria. The other projects presented covered: tackling epizootic animal diseases such as foot and mouth disease; how diet and hereditary factors can influence the risk of cancer; setting up a Europe-wide food and nutrition information webbased service; alternative fish feeds for healthier and greener seafood; improving the freshness of industrially pre-baked bread; cereals as a weapon against metabolic disorders; and a sustainable network integrating international food research institutions. ### EU MARIE CURIE FUND BACKS RESEARCH INTO SUGAR-BASED ANTI-CANCER DRUG

An Italian scientist supported by the EU's Marie Curie research fund is helping to pioneer a new treatment that could lead to a breakthrough in the fight against brain cancer. <u>More</u>

# SOCIAL AFFAIRS

# EU LAUNCHES PUBLIC DEBATE ON THE FUTURE OF PENSIONS

On 7/07, the Commission has launched a Europe-wide public debate on how to ensure adequate, sustainable and safe pensions and how the EU can best support the national efforts. Ageing populations in all Member States have put existing retirement systems under massive strain and the financial and economic crisis has only increased this pressure. The consultation document, a Green paper aims to address the following issues:

- Ensuring adequate incomes in retirement and making sure pension systems are sustainable in the long term
- Achieving the right balance between work and retirement and facilitating a longer active life
- Removing obstacles to people who work in different EU countries and to the internal market for retirement products
- Making pensions safer in the wake of the recent economic crisis, both now and in the longer term
- Making sure pensions are more transparent so that people can take informed decisions about their own retirement income

# STATE AID: COMMISSION APPROVES UK PENSION SCHEME NEST

The Commission has approved under EU State aid rules the establishment of an occupational pension scheme, branded NEST, in the UK to ensure that all employees have access to an affordable pension vehicle. The scheme, part of a wider pensions' reform in the UK, is meant for low to moderate income earners that the existing market does not serve. The Commission found the measure to be compatible with EU State aid rules, because NEST carries out a service of general economic interest (SGEI) and receives no overcompensation for providing it. #### STATE AID: COMMISSION AUTHORISES € MILLION COMPENSATION FOR SUPPLEMENTARY PENSION LIABILITIES OF FINNISH SHIPPING COMPANY ARCTIA SHIPPING OY

The Commission has authorised under EU state aid rules a Finnish aid to compensate the newly established shipping company Arctia Shipping Oy, for supplementary pension rights accrued by its staff before Finland opened up the ice-breaking activity. The Commission considers this measure necessary to put the company on an equal footing with its competitors. <u>More</u>

# HALF OF EUROPEANS WOULD CONSIDER MOVING FOR WORK

On 13/07 the Commission has adopted a report setting out in a consolidated way the rights of Europeans to live and work in another EU country. The report also provides an update on legal developments in the past decade. Currently, 2.3% of people in the EU reside in a Member State other than their own. However, a new Eurobarometer survey finds that 17% of Europeans envisage working abroad in the future and 48% would consider looking for work in another country or region if they were to lose their job. <u>More – MEMO-EN – Eurobarometer survey\_EN</u>

# AIDS: ENSURING AFFORDABLE MEDICINES AND FIGHTING DISCRIMINATION

Over 33 million people are living with AIDS world-wide and access to antiretroviral treatment remains poor. On 8/07, the EP approved a resolution calling on governments to pass new laws ensuring more affordable medication and to avoid free trade agreements that favour the commercial interests of the pharmaceutical sector over health needs. The resolution, adopted by 400 votes to 166, with 55 abstentions, was tabled by the following political groups: S&D, ALDE, Greens/EFA and EUL/NGL. <u>More</u>

### MEPS CALL FOR BAN ON FOOD FROM CLONED ANIMALS

MEPs renewed their appeal for a ban on food from cloned animals when they voted on novel foods legislation on 7/07. They also demanded a moratorium on foods using nanotechnology until potential health risks can be ruled out. If Council does not accept this secondreading position of the Parliament, an agreement will be sought through the conciliation procedure. <u>More</u>

### EUROPEAN YOUTH GUARANTEE

A "European Youth Guarantee" to ensure that young people who are unemployed do not remain jobless for more than four months is among proposals made by MEPs in a resolution on improving access to the labour market for young people. Amid the economic crisis, youth unemployment is increasing faster than the average rate. Remarkably, "more than 5.5 million young people in the EU under 25 were unemployed in December 2009, equivalent to 21.4 % of all young people", says a resolution drafted by Emilie Turunen (Greens/EFA, DK) and adopted in Strasbourg on 8/07. <u>More</u>

### DEBATE ON PATIENT 'HEALTH LITERACY'

On 24/06, a debate took place in the EP on health literacy. The International School for Public health and Primary Care at the Maastricht University is conducting a survey on European health Literacy. First results of this survey are expected in October 2010. # EU COURT OF JUSTICE

No 67/2010 : 1 July 2010, <u>Judgment of the General</u> <u>Court in case T-321/05 AstraZeneca v Commission</u> - (<u>DE</u> - <u>EN</u> - <u>FR</u>). Competition: The General Court essentially upholds the decision of the Commission which found that the AstraZeneca Group abused its dominant position by preventing the marketing of generic products replicating Losec. However, the fine of €60 million has been reduced to €52.5 million because the Commission failed to prove that the deregistration of the marketing authorisations of the medicinal product in certain Member States was capable of having an impact on parallel imports.

#### INVITATION TO MEPS TO TRANSFROM THE PROPOSED DIRECTIVE ON INFORAMTION TO PATIENTS INTO REAL PROGRESS FOR PATIENTS

In view of the EP ENVI vote in September on information to patients MiEF (of which AIM is member), HAI Europe and ISDB urge MEPs to vote

for the amendments aimed at enhancing access to nonpromotional, independent and comparative information. Efforts should first be focused on the information held by the European and national Drug Regulatory Agencies, whose lack of transparency is coming under increasing scrutiny, particularly by the European Ombudsman. ## **HEALTH SPENDING CUT**

# GERMANY CUTS HEALTH CARE SPENDING AND RAISES PREMIUMS

Faced with an estimated deficit of €11 billion in 2011 in the health care system, the German government decided to raise the contribution rate, shared roughly equally between worker and employer, from 14.9% to 15.5 % of a worker's income, according to Bloomberg.com. The measure is expected to bring in about €6 billion to aid the ailing insurers. In addition, there will be cuts of about €3.5 billion spread out among hospitals, physicians, dentists, insurers and pharmaceutical companies. In addition, the government has lifted the ceiling for the additional contributions (*Zusatzbeiträge*) that sickness funds can charge enrollees from 1% to 2%.Surcharges exceeding 2% of an insured's gross pay will be financed from general tax revenue. <u>More</u>

# NHS SHAKE-UP GRANTS NEW POWERS TO DOCTORS AND PATIENTS

According to the English MOH long term vision of NHS, "Equity and excellence : liberating the NHS the reform will lead to the abolition of all 10 strategic health authorities and the 152 management bodies known as primary care trusts, says BBC News. GPs, in consortiums, are to be handed £80bn of the NHS budget to buy care from hospitals and other doctors for patients in their area, as hundreds of middle-management organisations are swept away. The consortiums will be answerable to an independent Commission Board which will set objectives for healthcare, monitor performance and guide doctors in purchasing care. Patients, meanwhile, are to be given a wider choice on where to be treated and they will be asked if their care was effective and lived up to their expectations. All hospitals are to become a Foundation Trust or part of one, giving them far greater freedoms from Whitehall and allowing them to earn more money from private patients. However, the Labour and the unions, saying handing £80bn to GPs who are private contractors was a mistake and that the plan was a 'Trojan horse' for widespread privatisation

# SCOTTISH NHS REQUIRES RADICAL RETHINKING TO AVOID "TERMINAL COLLAPSE"

The inexorable rising trend in healthcare spending to meet demand, which has consistently risen at a higher rate than growth in the economy, is unsustainable, says a report by Scottish based think tank <u>internationalfuturesforum</u>. High spending on health care does not equate with the best population outcomes. Existing NHS strategies to contain spending, like efficiency savings, increased competition, restrictions on activity, and freezing pay, have been ineffective and have led to undesirable knock-on consequences. Further innovation to make the existing model work better merely postpones the system's inevitable decline and collapse. The report argues that low cost solutions such as helping people to develop their own capacity to cope with illness may be more important than fighting disease. <u>More</u>

## CUTTING WELFARE SPENDING COSTS LIVES

A study in the British Medical Journal finds that levels of social spending in Europe are 'strongly associated' with risks of death, especially from diseases relating to social circumstances, such as heart attacks and alcohol-induced illness. The conclusion is that it's not just health spending that needs to be ring-fenced but welfare spending too. In fact, the research suggests that social spending is more significantly associated with mortality from diseases related to social circumstances (such as alcohol related deaths) than healthcare spending. The researchers found spending on social welfare to promote health, and not simply healthcare, had the greatest impact on public health. It is a key determinant of future population health that should be taken into account in ongoing economic debates. Budget crises, health, and social welfare programmes

# GROWING HEALTH SPENDING PUTS PRESSURE ON GOVERNMENT BUDGETS

In some countries the recent economic downturn, with GDP falling and healthcare costs rising, led to a sharp increase in the ratio of health spending to GDP, says OECD. In Ireland, the % of GDP devoted to health increased from 7.5% in 2007 to 8.7% in 2008. In Spain, it rose from 8.4% to 9.0%. Given the urgent need to reduce their budget deficits, many OECD governments will have to make difficult choices to sustain their healthcare systems: curb the growth of public spending on health, cut spending in other areas, or raise taxes. Indeed, in all OECD countries total spending on healthcare is rising faster than economic growth, pushing the average ratio of health spending to GDP from 7.8% in 2000 to 9.0% in 2008, according to OECD Health Data 2010. Factors pushing health spending up - technological change, population expectations and population ageing - will continue to drive cost higher in the future. More

## **HEALTH PERFORMANCE**

# STUDY RANKS U.S. LAST AND THE HETHERLANDS FIRST ON HEALTH SYSTEM PERFORMANCE

Despite having the most expensive health care system, the US ranks last in overall performance compared with six other industrialized countries (Australia, Canada, Germany, the Netherlands, New Zealand, UK), according to a Commonwealth Fund report. The authors, who compared performance on measures of quality, efficiency, access to care, equity, and the ability to lead healthy and productive lives, found that while each country has room for improvement, the U.S. stands out for not getting good value for its health care dollars. Per capita health care spending in the U.S. was \$7,290 in 2007, compared with \$3,837 in the Netherlands, which ranked first in overall performance. The authors hope that with enactment of the Affordable Care Act, however, the US will begin strengthening primary care and investing in health information technology and quality improvement, ensuring that all Americans can obtain access to high quality, efficient health care.

### REFORM

### US REFORM: GOOD OR BAD?

Is US health reform a "monumental system transformation or a fatally flawed compromise?" The answer to this question by an American economist in a conference, was "yes", says an analyst in the BMJ. It is clearly the right answer because the health reform bill is so complex and contains so much that it's impossible to predict its effects. Indeed, health systems are "complex adaptive systems" where even small and simple changes may have unexpected results. According to the economist, three factors that meant that reform was unavoidable and the status quo unsustainable, are: many millions had no health insurance, US had much higher expenditure and lower life expectancy to other developed countries, the ballooning costs of Medicare. What happens will be determined by the effectiveness of implementation, which is highly complex, the behaviour of providers, employers, and individuals, and whether Congress feels the need to interfere, says the economist. # PHARMA JOINT VENTURE TARGETS DISEASE MANAGEMENT

The American Medco and the German Celesio, 2 giant pharma distributors, have set up a 50/50 joint

venture to help European payors to run better and more effective chronic disease management programmes (DMP), according to PRNewswire. The new company, Medco Celesio BV, based in Holland, might partner with, or could compete with, existing private operators of DMP in Europe, such as Healthways, BUPA's Health Dialog, Pfizer Health Solutions and numerous national players. It could even cover diagnostics. The joint venture is initially planned to go into operation in Germany in 2010, including the collaboration of the parent companies' respective mail-order pharmacies, DocMorris and Europa Apotheek Venlo. It will then extend rapidly in phases to the major European markets, including U.K., France, Spain and Italy. <u>More</u>

# UK DOCTOR ASSOCIATION REPRESENTATIVES VOTE TO BAN HOMOEOPATHY FROM THE NHS

Homoeopathic hospitals and remedies should not be funded on the NHS in UK, given the absence of valid scientific evidence of benefit, representatives voted at the British Medical Association's annual conference, according to the BMJ. They also voted that no UK training post should include a placement in homoeopathy and that pharmacists should remove homoeopathic remedies from their shelves indicating they are drugs: they should place them on shelves clearly labelled "placebos." ### ENGLISH 'NICE' RECOMMENDS THAT THE FOOD INDUSTRY CUT SALT, SUGAR, AND FAT TO SAVE LIVES

The National Institute for Health and Clinical Excellence (NICE) has issued guidance aimed at saving "tens of thousands of lives" in England by focusing on the effect that food production has on the nation's diet, says the BMJ. The guidance targets three "toxic components" salt, trans fats, and saturated fats. "Everybody has this idea that prevention is worthy but that you don't get the benefits for decades. This is wrong. You get rapid changes in 2 to 3 years," said the authors. It is supported with the examples of public health intervention programmes from Poland, Cuba, and the US, where for every dollar spent on health intervention in the US a corresponding €5 saving was seen in terms of reduced health costs. As well as targeting the food industry NICE's guidance calls for negotiations to occur at EU level to ensure that the Common Agricultural Policy takes account of public health issues and further recommends that local planning authorities restrict planning permission for fast food outlets near to schools. Other suggestions include using a pricing policy to make unhealthy foods less affordable. "There are definite parallels with tobacco control". More


