### La Concertation celebrates its 5<sup>th</sup> Forum in Cameroon

From 29 September until 1 October the Forum of La Concertation met in Yaoundé, Cameroon. It was its 5th edition since its creation in 1998.

The Forum 's theme was "10 years mutuality in Africa: reality, tendencies and challenges". During two days, about 400 participants from 18 African countries exchanged experiences, discussed health and access issues in a variety of workshops. Main issues for discussions were the conditions and functioning of healthcare mutuals, the role of mutuals in making healthcare accessible and universal healthcare coverage. The Forum took place with the support of the platform of promotors, of which AIM is a member.



# Union Africaine de la Mutualité formalises structures and work

On 2 October 2009, the Board of the Union Africaine de la Mutualité (UAM) met to discuss and to decide about the future functioning of the young association. At a session in Yaoundé, to which the Moroccan Ambassador to Cameroun assisted, the Board re-affirmed its interest in the Union and the future co-operation. It not only reaffirmed the Presidency of Mr. Abdelmoula Abdelmoumni, it also installed a Permanent Secretariat in Morocco and nominated Mrs Nadia Semlali as its Director.

#### Declaration of Yaoundé: Recognition of mutuals as adequate answer to local healthcare needs

The 5<sup>th</sup> Forum of La Concertation has adopted the declaration of Yaoundé, calling for recognition of healthcare mutuals as an adequate response to local healthcare challenges. The participants, in their declaration, urged national governments to take all necessary initiatives to ensure the information provision, the promotion and the development of healthcare mutuals. Specifically, the Declaration calls international agencies to continue their financial support and engagement in the development of mutuals in Africa.



#### Moroccan Abdelmoumni continues as a President of the Union Africaine de la Mutualité

Mr. Abdelmoula Abdelmoumni has been confirmed as President of the Union Africaine de la Mutualité (UAM). His election came after Mr. Mohammed El Farrah left office earlier this year and who has hold the Presidency since the creation of UAM in 2007.

Abdelmoula Abdelmoumni had been elected President of MGPAP, as a successor to Mr. Mohammed El Farrah, in June this year.
