## Tripartite round table on pension trends and reforms (30 November - 4 December 2020) Agenda

- > <u>Duration:</u> Plenary and Group meetings will be held from:
  - **Monday 30 November to Friday 4 December from 12:00-14:00 hrs GMT** (with the exception of Thursday 3 December).

On Thursday 3 December no meetings will be organized (neither plenary nor Group) in order to allow the Groups to reflect on and prepare their main take-away messages.

- > <u>Country cases:</u> For the country case reviews:
  - the representative from the <u>Government</u> of the respective country will have <u>5</u> <u>minutes</u> to present the main highlights of the countries' pensions system with respect to the principles indicated in the questionnaire;
  - the representatives from the <u>Employers' and the Workers'</u> of the respective country will have <u>3 minutes each</u> to present the main highlights of their countries' pensions system with respect to the principles indicated in the questionnaire.
- Each country case presentation will be followed by opening the floor to reactions (4-5 minutes) from the participants and to eventual comments by the spokespersons of the Employers' and Workers' group.
- Prior to the tripartite round table, each participant will provide a narrative of a maximum of 2 pages from which the participant can distil the main issues to be presented orally during her/his presentation. The written narrative should summarize the main issues related to the extent to which their countries' pensions system is complying with the ILO principles addressed in the questionnaire they would have completed, as well as the extent to which any on-going or planned pension reforms or discussions are complying with the ILO principles. This written narrative will be made available to all the participants to the tripartite round table.
- Group meetings: The individual Groups (G, E, W) will meet in separate group meetings to prepare their take away messages.
- Presentation by Groups of main take-away messages (2 hours): The last day of the tripartite round table (Friday 4 December) will be dedicated to the presentation of the take-away messages from each of the Groups. Each Group will be allocated 25 minutes to present their statement. Following these presentations, 30 minutes will be allocated to reactions from participants.
